LIFE MEMBERSHIP CRITERIA (SBA CONSTITUTION)

Life Member means an individual appointed as a Life Member of the Association under **clause 5.2**.

5.2 Life Members

- a) *The Board may recommend to the annual General Meeting that any natural person who has rendered distinguished service to the Association be appointed as a Life Member.*
- b) *For the purposes of the Constitution, 'rendered distinguished service' shall be restricted to those who have contributed to the control, promotion, integration, or fostering of participation and development of Basketball by their participation in the Association for a period of ten (10) years and who have never been charged and found guilty of an offence under and disciplinary process that warranted a suspension of greater than ten (10) weeks and are nominated by a member to the Board for election at an annual General Meeting of the Association.*
- c) *Nominations for Life Membership shall be delivered to the association not less than twenty-five (25) days before the date fixed for the annual General Meeting.*
- d) *Nominations must be in writing on the prescribed form, signed by one (1) Individual Member whose membership period end date is greater than the date of the annual General Meeting and signed by the nominee. Shoalhaven Basketball Association Incorporated Constitution Page 7 of 29*
- e) *A resolution of the annual General Meeting to confer life membership (subject to clauses 5.2 c) and d)) on the recommendation of the Board must be a Special Resolution and must be passed by at least three fourths (75%) of those members attending and eligible to vote.*
- f) *No more than two (2) Life Members may be elected at any one annual General Meeting.*
- g) *A person must accept or reject the Association's resolution to confer life membership in writing. Upon written acceptance, the person's details shall be entered upon the Register, and from the time of entry on the Register the person shall be a Life Member.*
